Meeting Notes, Decisions, Issues

- 1. DS welcomed Carry Murphy KBC Planning officer to the meeting
- 2. Apologies from Counciller June Derbyshire
- 3. Last minutes taken as read
- 4. No matters arising from last minutes
- 5. DS announced that Hillary Conelly had resigned due to her fathers death. The meeting thanked Hillary for her hard work for the SG up to now. DS asked for more volenteers to fill SG empty places
- 6. Questions from members of the public present
 - a) Garry Wynne moved from Manchester to the Town, the selling agents promised that investment in the town was going to be done. He felt that the area was now diminished, the Lawrence site disgraceful.
 - b) BH said that plans had been drawn up to improve the site. JW said this is what the Neighbourhood Plan SG is here for, to be consulting with residents. DS said that the site had been empty for around 10 years and had been owned by Tesco, Midlands Co-op and now by KBC. BK thanked Garry Wynne for his comments.
 - c) Rod Adams said the Town had been forgotten. KBC councillors promised to help with the Leisure Centre, but voted against keeping it. Market Harborough centre is heaving and busy. The schools are not good enough. Desborough has loads of houses but no infrastructure.
 - d) JW said that land should be put aside for Montsaye 6th form college in Desborough.
 - e) NP Questionaires were handed to all members of the public present.
 - f) Mary McNealy said the town has potential and the time is right for improvement. She also said that the Lawrences Site should be retail/commercial and not housing.
 - g) Carry Murphy KBC said that the Assets Department at KBC had no connection with the Planning Department, their duty was to achieve the best value for KBC when disposing of property. She said that the SG was looking at the right things regarding financing improvements to the town.

7. Finance Officers report – AM

A discussion took place at spending the £7k grant from Locality.

- a) AM mentioned that the spend was £410 more now.
- b) AmM showed that £5762.80 was current spen with £5400 for consultants leaving £362.80 left.
- c) An amount of £6300 spent could bring a further £700.
- d) PH to look into varience.
- e) DS to write a report to Town Council about money spent so far.

8. Project managers report GH.

- a) On track with plan, one item outstanding DS contacting Statuary bodies. DS stated that the consultants were undertaking this action.
- b) BK report on Health needs. He has contacted NGCG, Kettering Locality Forum, need to speak to Nicola Warren of Desborough & Rothwell Surgeries, Need to contact KGH also, the organising of Health issues very complicated. Thanks to BK for his work.
- c) AM mentioned Kettring, Corby, Wellingborough and Desborough & Rothwell have plans to merge into a Super Surgery.
- d) Mary McNealy that Kibworth Council are suing developers for non-payment of S106 payments.
- e) Next meeting should include an item on communication with residents.
- f) Project Plan will be available on website when ready.
